FULL-TIME EMPLOYEES (FTE)

Use FTE numbers where FTE stands for full-time employees or full-time equivalency. FTE can be computed by using total hours worked/2080 hours for a fiscal year. Estimate to the nearest tenth. If an employee works part time for more than one industry then determine FTE based on estimate of hours worked per industry.

Example: An employee worked 35% of their time on electric jobs, 30% on water jobs, 20% on sewer jobs and 15% on municipal nonutility jobs. The FTE by industry would be .4 for electric, .3 for water and .2 for sewer.

Account 923 - In 2005 there were union negotiations and during '06 there were not. Also some legal fees were incurred during the water project in '05 but not in '06.

Account 926 - Health insurance increased due to an additional employee working for the water department for 8 months. There was also an increase in health insurance premiums from 2006 compared to 2005.

Account 652 - more labor was needed at the treatment plant
