Account 682 Outside Services Employed - The Utility incurred less cost relative to the audit and accounting functions due to the Utility/Clerk having additional experience from serving in the function for a longer period of time. This was the case for the first portion of 2007; however, the position was vacant and has now been filled but will probably require additional costs in 2008.
